# of the Asset Management Company

The board of directors of ITOCHU REIT Management Co., Ltd. (IRM), the asset management company to which Advance Residence Investment Corporation (ADR) entrusts the management of its assets decided today to change the organization as below.

### 1. Organizational Changes

### (1) Details of Changes

#### Abolition of the Logistics Division and related departments

The absorption-type company split agreement (Note) concluded between IRM and Mitsui Fudosan Logistics REIT Management Co., Ltd. on August 5, 2024 will come into effect on November 1, 2024.

In relation to this matter, IRM will abolish the Logistics Division (and its related departments, Logistics REIT Department and Logistics Strategy Department), which is in charge of the asset management of Advance Logistics Investment Corporation.




